

 use SEMS resources to support wider work. All to begin considering how we
 can manage or reduce those activities that are impacting using existing
 powers and functions.
- Action: All to use the Solent Plastics Pollution hub <u>media pack</u> to help publicise this initiative. First annual review now available.
- Action: All to publicise and use the 101 Police reporting facility to report ASB on the coast and in the marine environment.
- Action: All to consider downloading and publicising the <u>Project Kraken</u> <u>poster</u>.
- All to please provide any evidence that can be used in the SPA condition assessment process for MPAs to Jessica Taylor once these begin.

Annual Management Report Format

- Annual Survey reviews seventeen non-licensable activities that take place around the Solent
- Annual Survey asks about changes in activity levels and whether respondents think that an activity is impacting on the designated sites
- Annual Management report evaluates the survey findings and other relevant data collected by the SEMS Officer. Three sections for each activity:
- 1. Summary of the survey response
- 2. Evaluation and discussion incl. information on impacts and management measures. NE states if activity having detrimental impact on SEMS sites.
- 3. Actions

Headline Findings of Annual Survey 2023

- 1. 28 out of 31 Relevant Authorities responded to the Annual Survey.
- 2. Increases in activity recorded at more than one site were for non-motorised watercraft, FCERM, operation of ports and harbours and shore-based fishing. Mode for all activities is 'no change'.
- 3. Activities highlighted by multiple respondents potentially *impacting* on SEMS sites included: **coastal walking (incl walking with dogs)**, **litter**, **the use of motorised and non-motorised recreational watercraft**, **general beach recreation and FCERM**.
- Trend data (2019 to 2023) shows that it is non-motorised watercraft that had year on year increases across the Solent, although not in 2023 (paddlesports).
- 5. For activities where we are seeing 'no change' this does not mean that they are not having an impact, as the current levels could still be causing damage to designated sites.

SEMS Draft AMR Comments



- Bird Aware queried how the SEMS process can be used to address disturbance from marine non licensable activities more effectively.
- Need to ensure that Bird Aware Partner liaise with Bird Aware rangers when completing annual survey returns.
- How do we capture unconsented coastal developments in the Annual Survey to monitor the potential impacts from their operation?

SEMS MG Generic Actions 1 (section 6)



- 1. SEMS MG members should use this Report and the <u>activity pages</u> on the SEMS website as a reference resource to help shape relevant plans and policies or management measures for activities in designated sites. SEMS MG members are also encouraged to share these resources more widely and encourage the adoption of best practice by private landowners.
- 2. SEMS MG members to feed information on activities to the SEMS office throughout the year (sems@hants.gov.uk) to enable the promotion and sharing of good practice throughout the Solent.
- 3. SEMS MG members to use the <u>duty and responsibility table</u> to guide what activity sections they need to complete in the SEMS Annual Survey. To also be aware that Relevant Authorities have a responsibility to manage activities under their jurisdiction in the exercising of general duties.



SEMS MG Generic Actions 2 (section 6)

- 4. Trend data for activity change is showing that activities in the Solent are elevated but stable. For those activities where Relevant Authorities, particularly Natural England, are concerned about impacts on designated sites, we need to evaluate if and how we can reduce or better manage those activities; focusing on sites that are especially sensitive.
- 5. NEG to assist the Blue Marine led Solent Seascapes Project in identifying how anthropogenic activity pressure can be reduced and managed to help habitat and species restoration and the delivery of a voluntary restoration plan.
- 6. NEG to continue to collate and share information via the <u>Clean Solent Shores and Seas webpages</u> on water quality issues in the Solent's designated sites such as contaminants, nutrients and microplastics.

Solent Seascapes Recovery Plan KEY PROJECT

Formerly - Solent Bird Sensitivity and Activity Mapping (SBS) Project

- The Solent Seascapes Project Seascapes Recovery Plan Working Group (chaired by the Solent Forum) will take forward the SBS project.
- Solent Forum gave £30k funding towards the Seascapes Recovery Plan.
- ABPmer are designing and populating a data portal and preparing a State of Nature Report. The Solent Recovery Plan Working Group will co-design management options with stakeholders.
- ➤ It will set criteria for bird sensitive areas and understand issues of displacement.
- ➤ It will use current datasets and identify significant gaps. Will include Solent Mudflat Disturbance Project; paddlesports and other non-licensable activities.
- It will lead to an evidence based management strategy.



Impacts of Paddlesports in the Solent (IMP Solent)

'Develop the evidence base on the impacts of paddleboarding on the Solent's designated habitats and species, particularly birds, to explore suitable management options, using Chichester Harbour as a case study.'

Current status:

Chichester Harbour Conservancy is monitoring the incidence and effects of Paddlesports. Surveys began in October 2021 and will continue for at least two years. The Conservancy presented and provided year one results at NEG in April 2023 – <u>presentation</u> on NEG website.

Paddlesports are a non-licensable activity that will be included in the Solent Seascapes Recovery Plan.




Solent Plastics Pollution hub
