

Online annual Survey completed by SEMS Management Group (MG). Annual Survey Report published (ASR)

#### May/June

Draft Annual Management Report (AMR) prepared and discussed by officers and chairs of SEMS/NEG

#### **August**

Draft AMR circulated to MG and stakeholder group

#### **September**

Annual MG meeting agrees the AMR and its actions

#### Spring/Autumn

NEG meets to discuss and progress strategic actions

#### **SEMS MG Actions from 2024 Meeting**



- Action: KA to add generic action attributed to NEG to monitor and report on MMO marine non-licensable activity work. This is being monitored via the Solent Forum's news service and our membership on the national MPA officers working group. MMO contracted APEM Ltd to conduct Solent research and Hurst Spit and Langstone Harbour were identified as areas for potential management (awaiting report).
- Action: KA to draft clear wording to include in the 2025 Survey of how the options 'no change' and 'no data' should be applied. A new table (4b on P.16) has been included in the report that shows those activities recorded 'no data', this will help to focus NEG project spending.
- Action: Natural England to summarise in the Management Report which activities they think are having impacts. A new section (3.9.3) has been added to the Report (thanks to Jess Taylor)

- The Solent Forum will be changing host by 1 April 2026.

## **Annual Management Report Format**

- Annual Survey reviews sixteen non-licensable activities that take place around the Solent
- Annual Survey asks about changes in activity levels and whether respondents think that an activity is impacting on the designated sites, data for this report is from 2024.
- Annual Management report evaluates the survey findings and other relevant data collected by the SEMS Officer. Three sections for each activity:
- 1. Summary of the survey response
- 2. Evaluation and discussion incl. information on impacts and management measures. NE states if they think activity having detrimental impact on SEMS sites.
- 3. Actions

- 1. Accidental vessel discharges/emissions including oil spill and clean-up
- 2. Boat repair and maintenance
- 3. Fishing (including shellfisheries)
- Fishing (shore-based activities)
- 5. General beach recreation (change from land recreation other)
- 6. Grazing and foraging
- 7. Land recreation Walking (including dog walking)
- 8. Littering and removal of litter
- Mooring and anchoring
- 10. Operation of coastal flood and erosion risk management schemes
- 11. Operation of ports and harbours (maintenance of infrastructure)
- 12. Aerial Recreation
- 13. Recreation non-motorised watercraft
- 14. Recreation powerboating or sailing with an engine
- 15. Slipway and jetty cleaning and maintenance

#### **Headline Findings of Annual Survey 2025**





- 2. Increases in activity recorded at more than one site were for operation of FCERM and land recreation (walking). Mode for all activities is 'no change'.
- 3. The activities highlighted by respondents potentially *impacting* on SEMS sites are: coastal walking (mainly with dogs), littering, coastal squeeze (from FCERM works), and non motorised watercraft use (paddlesports).
- 4. Trend data (2019 to 2024) shows that the mode response to changes in activity levels across the Solent remains as 'no change'.
- 5. 'No change' does not mean activities are not having an impact, as the current levels could still be causing damage to designated sites. The Solent is a busy place..... (will see in Strava mapping)

- NEG to support the development of the Solent Seascapes project's Seascape Recovery Plan.
- All to use the <u>Solent Forum's Biosecurity plans</u> to help prevent the spread of marine invasives species from activities around the Solent.
- All to report wildlife disturbance from marine non-licensable activities via email to the MMO. The MMO are setting up an online reporting tool to assist with reporting in the future and we will share this once it has launched.
